#### A. ANTI-RAGGING COMMITTEE

Ragging is a punishable Offence. The Ministry of Human Resources Development (MHRD), following a directive by the Supreme Court, appointed a seven-member panel headed by former CBI director Dr. R. K. Raghavan to recommend anti-ragging measures. The Raghavan Committee report submitted to the court in May 2007, includes a proposal to include ragging as a special section under the Indian Penal Code. The Supreme Court of India interim order (based on the recommendations) dated 16 May 2007 makes it obligatory for academic institutions to file official **First Information Reports with the police** in any instance of a complaint of ragging. This would ensure that all cases would be formally investigated under the criminal justice system, and not by the academic institutions' own adhoc bodies.

As per the amendments made by UGC to its 2009 UGC Regulations regarding Ragging in Campuses,

» It is no longer required to get the verification of the affidavit done by an oath commissioner.

»The definition of ragging is updated to read: "Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.

#### **Objective:**

Anti-Ragging Committee (ARC) is a statutory body constituted to upkeep the safety and educational ambience on the campus and off the campus for its student community. The committee functions with the core objectives of upholding and uplifting the mission of the college and in doing so, enhances the quality of life at the campus by ensuring utmost safety to the student community. The members of the committee shall carry out functions that are relevant within the scope of the ARC policy by continuously contributing, monitoring, and enforcing the guidelines drawn by the UGC, the Government of Kerala and Mahatma Gandhi University Kottayam. The ARC Policy touches upon the functionality, procedure, principles, scope, ways, implementation and means of upholding the objectives set by the cell, for the college. This policy document will serve as a guide to the ARC members as well as to its stakeholders, in their mission to maintain the campus Ragging free.

#### **Functions:**

- > To organize awareness programmes on Ragging, its definitions and limits, the psychological and social implications, pertaining law and regulations, etc.
- > To ensure the submission of mandatory anti-ragging affidavits
- > To address related complaints from students

#### Regulations

#### UGC Regulation on Curbing of Ragging

As per the UGC Regulations 2009, 'Ragging' constitutes one or more of any of the following acts:

- any conduct by any student or students whether by words spoken or written or by an act which affects a fresher or any other student.
- b. Indulging in rowdy or indisciplined activities by any student or students which causes or is likely to cause annoyance hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- c. Asking any student to do any act which such student will not in the ordinary course do and which has the effect or causing in generating a sense of shame, or torment or embrassement so as to adversely affect the physique or psyche of such fresher or any other student.
- d. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student.
- e. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or group of students.
- f. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
- g. Any act of physical abuse including all variants of sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.
- h. Any act of abuse by spoken words which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- Any act that the mental health and self confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

# Punishment

The UGC regulations stipulate that students can be expelled from an institute and debarred from taking admission to any other institute for a specified period after being found guilty of the offence. Students can be fined up to Rs. 2.5 Lakhs if found guilty of the offence.

Depending upon the nature and gravity of the offence as established by the Anti- Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following.

- 1. Suspension from attending classes and academic privileges.
- Withholding/ withdrawing scholarship/fellowship and other benefits.
- Debarring from appearing in any test/examination or other evaluation process.
- 4. Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament, youth festival etc.
- 6. Suspension/expulsion from the hostel
- 7. Cancellation of admission.
- Rustication from the institution for period ranging from 1 to 4 semesters.
- 9. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.
- 10. Fine ranging from ₹25,000/- to ₹2.5 lakh.
- Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment.

The following committees are formed in the institution.

# Report based on the enquiry into the complaint lodged by a girl student against Dr.Minimol K.C. and the members of the Zoology department.

The girl student has complained that the teachers of her department strictly enforce that students leave the campus after class. During days of leave the students also have to submit a leave letter. Moreover, students are not allowed to mingle with their seniors and juniors. She states specifically that during her first and second year classes, her seniors too faced the same situation. Here, it is to be noted that during her first and second year, classes were held in the online mode. Since offline classes started only during the fag end of the second year and that too during the time of examinations, the complaint is not valid. Students are supposed to leave the campus after class by 5.00 pm.

The girl student has cited an example of a married senior student who had to face illtreatment and rebuke from the teachers. However, she does not know who that student is. She claims to have written that based on hearsay and has no direct knowledge about the same.

Threat of lowering internal marks is another complaint that the girl student puts forth. The internal mark of a particular paper is based on all the teachers teaching that subject and not the discretion of a teacher. Moreover, the university has specified strict guidelines on the marking pattern which has to be followed by the teaching faculty.

The girl student narrates a personal experience that occurred almost two months back - on August 30 – the day of the Onam celebration in the college. The girl student states that while she was sitting with her friend in the central circle of the college, Dr.Minimol asked her whether "it is a new connection?" This hurt her. **However, Dr.Minimol negates making that statement.** 

The girl student lodged her complaint on 26/10/2022, three days after the suspension order was submitted to two students of the college for alleged misbehavior to teachers. Most of the allegations are, she claims, based on the versions of some of her classmates and not hers. She also said that Dr.Minimol has not used the word "set up" as is alleged by the student leaders. She also welcomes the fact that because teachers are strict in academic matters she submits all her records and assignments in time helping her to score marks for her internals. Her only request is teachers do not involve too much in personal matters. She has given in writing that neither she nor Dr.Minimol should in no way be affected as a result of the complaint.

#### C. INTERNAL COMPLAINTS COMMITTEE (ICC)

Internal Complaints Committee (ICC) and a special cell in this institution, to deal with the issues of gender based violence and to conduct gender sensitization programmes

As part of its zero-tolerance policy against sexual harassment, Sree Sankara College, Kalady has constituted an Internal Complaints Committee in July 2023, by integrating the Anti-Sexual Harassment cell that has been functioning in the college. ICC is constituted under UGC (Prevention, Prohibition and Redressal of sexual harassment of women employees and students in higher education institutions) Regulations 2015, and applies to all higher educational institutions in India. According to this regulation, sexual harassment means:

An unwanted conduct with sexual undertones if it occurs or which is persistent and which demeans, humiliates or creates a hostile and intimidating environment or is calculated to induce submission by actual or threatened adverse consequences and includes any one or more or all of the following unwelcome acts or behaviour (whether directly or by implication), namely;

Any unwelcome physical, verbal or non-verbal conduct of sexual nature,

- Demand or request for sexual favours
- Making sexually coloured remarks
- Physical contact or advances » Showing pornography
- Any one or more than one or all of the following circumstances, if it occurs or is present in relation or connected with any behaviour that has explicit or implicit sexual undertones:
- Implied or explicit promise of preferential treatment as quid pro quo for sexual favours
- Implied or explicit threat of detrimental treatment in the conduct of work;
- Implied or explicit threat about the present or future status of the person concerned;
- Creating an intimidating offensive or hostile learning environment;

- Humiliating treatment likely to affect the health, safety, dignity or physical integrity of the person concerned
- The term of office of the members of ICC shall be three years. The list of office bearers are given below:

#### **Objective:**

The objective of the Internal Complaints Committee of the college is to create a safe, secure and supportive environment for women staff and students of the college, conducive to peaceful and effective teaching and learning.

#### **Functions:**

- Organizing awareness programmes on Gender sensitization, pertaining legal aspects, etc.
- Address complaints of sexual harassment from staff and students and take necessary action.


