Whereas

a) About **Sree Sankara Vidyapeetham College, Valayanchirangara.**

Sree Sankara Vidyapeetom College, founded five decades ago and managed by The SREE SANKARA TRUST, which was formed in 1965, for promoting higher education in conformity with the ideals propagated by the great saint. The beginning of Sree Sankara Vidyapeetom College at Sree Sankarapuram, Valayanchirangara marked a radical improvement in higher education and at the same time prompted a social awakening of multilateral aspects.

b) Sree Sankara College, Kalady was founded in the year 1954 by Swami Agamananda, a social reformer and a foresighted scholar of Sri Ramakrishna Awaitha Ashram. The institution was established with a view to perpetuating the memory and doctrines of the great saint and philosopher, Adi Sankaracharya and to nurture his birthplace as a cultural citadel. The institution was raised to the status of a first grade college in 1956. It is an Arts and Science College affiliated to Mahatma Gandhi University, Kottayam.

Whereas

Department of Hindi, Sree Sankara College, Kalady is desirous to associate with Department of Hindi, Sree Sankara Vidyapeetham College, Valayanchirangara on various areas as discussed in the Purview of this MoU, which will be mutually beneficial to both organizations.

The Institutions, subject to the terms of this MoU and the laws, rules, regulations and national policies from time to time in force in the country, will endeavor to strengthen, promote and develop cooperation between the Institutions based on equality and mutual benefit.

NOW THEREFORE THIS MEMORANDUM OF UNDERSTANDING WITNESSES AS FOLLOWS

I. OBJECTIVE

In accordance with a mutual desire, the purpose of this agreement is to establish a framework within which **both departments**, the Department of Hindi, Sree Sankara Vidyapeetham College, Valayanchirangara and Department of Hindi, Sree Sankara College, Kalady, as the second party have come to an agreement to collaborate to achieve the following objectives:

- ❖ Joint academic programmes;
- ❖ Collaborative faculty and staff development activities; and
- ❖ Other activities as mutually agreed.

II. DESIGNATED AUTHORITIES

The objectives of this MoU will be implemented through the coordination of the Hindi Departments of both Institutions. The persons designated to coordinate activities under this agreement will be the Heads of Departments of Hindi of both Colleges who further can designate/assign coordinators from other departments to implement specific cooperative activities as agreed upon in this MoU.

III. FINANCIAL COMMITMENT

This MoU will not give rise to any financial obligation by one Institution to the other. Each Institution will bear its own cost and expenses in the implementation of this MoU. Each Institution shall bear the respective costs of carrying out the obligations under this agreement. Neither Institution shall make a claim against the other Institution for any expenditure unless such expenditure has been agreed upon in writing between the Institutions.

IV. INTELLECTUAL PROPERTY RIGHTS

The intellectual property rights shall be enforced by this MoU in conformity with the national rules and regulations.



V. RIGHTS AND DUTIES

The institutions shall act as facilitators, but they will have no obligation whatsoever in terms of actions, behaviour or financial aspects of the students/ participants in the exchange.

VI SETTLEMENT OF DISPUTES

Any differences or disputes between the Institutions concerning the interpretation and/or implementation and/or application of any of the provisions of this MoU shall be settled amicably through mutual consultation and/or negotiations between the Institutions without reference to any third party, national or international tribunal.

VII TERM, TERMINATION, AMENDMENT AND RENEWAL

This MoU shall become effective on the date it is signed by the Institutions and shall be valid for FIVE years. This understanding may be amended by mutual written agreement and may be terminated at any time by either Institution upon THREE month's written notice to the other Institution.

The above MoU holds valid until any or all the parties to it, withdraw in writing from the same.

VIII. COMPETENT AUTHORITIES

The authorities responsible for the fulfillment of this MoU will be the Heads of the Departments of Hindi of both the Department of Hindi, Sree Sankara Vidyapeetham College, Valayanchirangara and Department of Hindi, Sree Sankara College, Kalady, as the second party.

REPORT OF THE 2 DAY WORKSHOP ON HINDI DRAMA

Dr. Sunitha Gopalakrishnan, Prof. Dept of Hindi, SSUS Kalady, inaugurated the programme. Dr. Ratheesh C Nair, HOD, Dept of Hindi, presided the function. Dr. Preethi Nair, Principal, and Dr. Manju T IQAC co ordinator felicitated the function.
