MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:


CLAUSE 1 CO OPERATION



INTELLECTUAL PROPERTY**

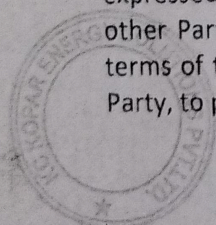
