Areas of Collaboration:

The parties agree to collaborate in the following areas:

- a. Development of digital tools and technologies for the digitization of Sanskrit texts and Indian Knowledge Systems.
- b. Joint research projects focusing on the analysis, interpretation, and preservation of Indian Knowledge Systems using computer science methodologies.
- c. Exchange of academic resources, including research papers, scholarly publications, and relevant literature.
- d. Organizing joint seminars, workshops, and conferences to promote interdisciplinary dialogue and knowledge sharing.

Responsibilities:

- b. Sree Sankara Vidyapeetom College will provide expertise in computer science and related technologies, develop digital tools and methodologies for the digitization of Indian Knowledge Systems, and contribute to the technological analysis and interpretation of the digitized content.

Funding and Resources:

The parties shall seek external funding and resources to support collaborative projects and initiatives. They will jointly explore grant opportunities, scholarships, and sponsorships to ensure the successful execution of the collaboration.

Duration and Termination:

This Agreement shall commence on the date of signing and shall remain in effect for a period of three years. Either party may terminate this Agreement by providing written notice to the other party at least [notice period] prior to the intended termination date.

Intellectual Property:

Any intellectual property created jointly during the collaboration shall be jointly owned by Sree Sankara College Kalady and Sree Sankara Vidyapeetom College, unless otherwise agreed upon in writing by both parties.



Dispute Resolution:

Any disputes arising from this Agreement shall be resolved amicably through negotiations between the parties. If the dispute remains unresolved, the parties agree to pursue mediation or arbitration as a means of resolving the dispute.

Governing Law:

This Agreement shall be governed by and construed in accordance with the laws of our Country. Any legal actions or proceedings arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts in India.


