**WHEREAS:**

Therefore the parties in after have intended to enter into this MoU which agreed and consented the following objectives, terms and deeds in pursuance of a common intent to promote Sanskrit and develop interest in Sanskrit of their students.

**1. Objectives**

- Sharing the expertise of faculty reciprocally for the achievement of any objectives mutually agreed by the parties under this MoU.
- Exchange of academic materials and publications of Sanskrit.
- Conducting lectures, Certificate courses, seminars/ webinars etc.
- Participating in seminars/ webinars symposiums and other types of academic discussions .
- Permit students and faculty members reciprocally to use library facility with specific prior sanction of the parties.

## **2. METHOD FOR ACHIEVING THE OBJECTIVES:**

In order to achieve the aforementioned objectives, both parties, in mutual agreement, shall develop cooperation programs and projects that will specify the commitments each of them is to make for the performance of said programs.

- i. *Faculty Exchange with Partner Institution:* Faculty members of both parties can travel between to participate in activities that can enhance their international / national experience and knowledge and also to foster relations between the parties. Activities include, but are not limited to, delivering lectures, teaching a course, taking a sabbatical, acquiring skills for departmental governance and developing collaborative research etc.
- ii. *Student Exchange with Partner Institution:* Students can be given an opportunity to travel among parties to participate in activities / events that will enhance their international/ national / intercultural experience and knowledge.
- iii. Cooperate in the exchange of information relating to their activities in teaching and research in fields of mutual interests; sharing best practices adopted by each parties; sharing of e-content between the parties; access to library and repository services, if possible.
- iv. Conduct lectures, Certificate courses, seminars/ webinars etc.  
cultural projects, study tours, as mutually agreed in writing between the parties prior to commencement of this activity.

The objectives stated above define the framework for the cooperation of the parties in the following sections.

### **3. FUNDING:**

Expenses for transportation, room and board and personal expenses of exchange students, teachers or officers shall be covered by each individual.

### **4. AUTONOMY:**

- a) This agreement is a statement of intentions and does not involve, in any instance whatsoever, any financial obligations between the subscribing institutions.

**5. CONFLICT RESOLUTION:**

- a) Any dispute resulting from the interpretation or application of this Agreement shall be settled through direct negotiation and **common agreement** by the persons delegated to such end by each Institution. Either party may propose to the other a modification of the Agreement at anytime in writing.

**6. CONFIDENTIALITY:**

- a) Each of the parties accepts and declares that every information from the other party is of a confidential nature, is the exclusive property of the latter and has been or will be disclosed to the former solely with the purpose of enabling the full accomplishment of the present Agreement. For this reason, every piece of information provided by one party to the other before signing this Agreement and/or during its performance must be kept confidential and therefore may not be disclosed to any third parties.

**7. AMENDMENTS:**

- a) The parties may amend or amplify this Agreement through agreements in writing to that effect. Said amendments or additions will be binding on the signatories as of the date of their signature. The parties may not assign, in whole or in part, the performance of the present MoU to any third party, except through prior and express authorization in writing by both of them.

And since both parties are in agreement regarding the content of the present document, and as a token of conformity, we sign it in two counterparts, both of which will be considered originals.

**8. PERIOD**

This MOU shall remain in force for a period of one year from the date of its signature and seal and cannot be terminated by either side without mutual consent.

The parties to the memorandum with the consent and approval of their institutional authority may, by mutual consent, add, modify, amend, delete, review, or revise any term(s) and condition(s) of this agreement

6. This Letter of Linkage should be reviewed every year to evaluate the progress and quality of the mutual cooperation. It may be extended to additional five year periods upon the written consent of both the parties. If the Letter of Linkage is not renewed by mutual consent, then it will conclude at the end of the specified time period, or after activities in progress have concluded.
7. This Letter of Linkage may be terminated by either party with a minimum of 120 days written notice. Activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed.
8. Both institutions subscribe to a policy of equal opportunity and will not discriminate on the basis of race, religion, colour, sex, age, national origin or ancestry, marital status, parental status, disability or veteran status.
9. Each party shall designate a person or office to serve as liaison for implementing this Letter of Linkage. For St.Peter's College, Kolenchery the contact person will be Dr.Gracy K S, Assistant Professor, Coordinator of the course, Department of History. For Sree Sankara College, Kalady, the contact person will be Dr. K V Suji, Assistant Professor, Coordinator of the Course, Department of History.
10. This Letter of Linkage is written in English.

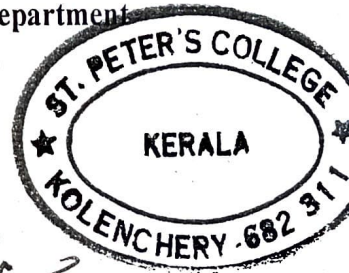




## **LETTER OF LINKAGE**

St.Peter's College, Kolenchery, Ernakulam District, Pin-682311, Kerala, India and, Sree Sankara College, Kalady, Ernakulam District, Pin-683574, Kerala, India, establish this Letter of Linkage to foster cooperation in educational Activity, Certificate Course in History- Museology in India.

1. Both parties agree to conduct a certificate course in History, Museology in India and to encourage the following activities, in particular to promote academic cooperation;

### Detailed Report

The Sanskrit department of Sri Sankara College signed an MOU with St. Peter's college , Kolanchery on 28th June 2022. The title is “ Lecture series on Sanskrit literature. The aim of this venture is to disseminate knowledge among the upcoming generation by giving an outline of Sanskrit literature tradition. The classes were conducted in online mode and completed with 30 classes. Students from both Sri Sankara college and St. Peter's college gained the benefit of lectures.
